

Solo Dock Limited Warranty

Warranty Coverage: Solo Dock warrants its products to be free of defects in material or workmanship from the date of sale for the time periods set forth herein: Solo Dock products carry a 15 year conditional warranty on aluminum parts, and a one year warranty on powder coating paint/finish.

Warranty coverage does not include dents, punctures, scratches, damage to the finish, or failures resulting from such damage. The terms of this warranty are valid for residential use only and are not valid for any commercial use of a Solo Dock. The terms of the warranty extend from the date of retail purchase by the original purchaser, and apply only to new Solo Dock product itself and not to any other components supplied by others. This warranty is not transferrable or assignable. Customer must complete and submit the warranty information and receipt with 30 days of purchase.

Exclusion From Coverage:

To the maximum extent permitted by law, Solo Dock shall not be liable for any costs, loss, expense, damages, special damages, incidental damages or consequential damages arising directly or indirectly from the installation, use, misuse, misapplication, improper selection or inability to use this product. This exclusion applies regardless of whether such damages are sought based on breach of warranty, breach of contract, negligence, strict liability in tort, or any other legal theory. Should the company nevertheless be found liable for any damages, the total liability of the company shall be limited to the purchase price of the particular product at issue.

The terms of this express warranty exclude product failures which are the result of:

1. Accident, abuse or improper installation, removal or use
2. Improper or insufficient handling, storage, maintenance, service, improper adjustment, modification
3. Use of the Solo Dock in a saltwater environment
4. Damage caused by fire, snow, ice, frost, electrolysis, hail, severe weather, floods, acts of God, wind, waves, current, high water, tree sap, or chemicals. (Coverage may be available through a homeowner's insurance policy.)

Warranty is void when misuse or neglect is the cause. Specifications are subject to change without notice. Solo Dock is not responsible for removal, dismantling or reinstallation cost. This warranty is void if the dock is used in other-than-normal residential service, or installed in salt water.

Warranty Claim Procedure: In the event of a warranty claim, send written notice of any claim by certified U.S. Mail to Solo Dock, 1687 Concordia St., Wayzata, MN 55391 immediately upon discovery of the defect.

The written notice must include the following information:

1. Name, address, telephone number
2. Proof of sale, detailed original copy of receipt, place of purchase and date of purchase
3. Detailed explanation of defect

Remedies: If the Solo Dock product is defective within the terms of this warranty, Solo Dock will, at its option, either:

1. Repair the Solo Dock without charge
2. Replace the Solo Dock

If Solo Dock is unable to provide a replacement and repair is not, in Solo Dock's judgment, practical under the circumstances, Solo Dock will refund the original purchase price of the Solo Dock.

Limitation of Remedies: The remedies set forth herein are the customer's exclusive remedies for breach of this warranty and any implied warranties. In no case shall Solo Dock be liable to the customer or any other person for any consequential or incidental damages or economic losses. Your Limited Warranty does not cover any incidental or consequential damages connected with the failure of your dock under warranty: such damages include lost time, inconvenience; the loss of the use of your dock; the cost of rental dock or slip; gasoline, telephone, travel or lodging; the loss of personal or commercial property; the loss of revenue, etc.

No Modification: No distributor, dealer or retailer has the authority to change or modify this warranty.

This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
